The Canada child benefit (CCB) is a tax-free monthly payment made to eligible families to help them with the cost of raising children under 18. It may include the child disability benefit (CDB), a monthly benefit providing financial assistance for qualified families caring for children with severe and prolonged mental or physical impairments.

To make sure that you are getting the right amount, you must inform us immediately if:

- you move
- your marital status changes or you change your name
- you or your spouse or common-law partner are no longer a resident of Canada
- the number of children in your care changes
- you start or end sharing custody of one or more children
- your banking information changes
- the recipient of this notice is deceased

Definitions

Base year: the year of the income tax return we use to calculate your benefit

Payment period: the 12-month period that begins in July and runs through June of the next year

Family net income: the net income from your tax return and, if applicable, your spouse's or common-law partner's return, **minus** any universal child care benefit (UCCB) and registered disability savings plan (RDSP) income you received, **plus** any UCCB and RDSP amounts you repaid during the tax year and any amount you claimed for total split income

If you want to register a formal dispute:
